



Booking conditions

Please take the time to read and understand the following conditions of registration prior to commitment to a Soul Culture Yoga Teacher Training with JaiShree. With a foundation of clarity and trust, we begin this wonderful healing journey towards bliss.

Our contract

All registration will be made with Deborah 'Jaishree' Dow-Spielman of JaiShree Yoga. By booking a training with me, we understand that you have agreed to all of the Booking Conditions (which constitutes the entire agreement between you and me). Your booking will be accepted by me on this basis. You will receive confirmation of booking invoice via email.

Deposit requirement

For most of our trainings, a non-refundable deposit of \$500 USD is required for your registration to be confirmed. In the case of Payment in Full or Installment Subscription, please see Cancellation Policy below.

Acceptance of booking and final payments

Acceptance of your training booking will be confirmed in writing via PayPal receipt and/or email. Please refer to your booking confirmation invoice for details regarding final payments. Payment of the balance of the training fee is due 10 days before training commences if you pay in installments, and 2 months before training commences if you pay early admission or scholarship. Certification cannot be given until full payment processed.

Special Payment Plans & Scholarships

In the special case of payment plans including scholarships and extended payment, you the student accept that the payment in FULL is due by the end of the training, *and will be submitted whether or not you fulfill your 200-hr requirements to receive certification.*

Your details

In order for me to confirm your training booking, deposit/enrollment fee and personal information including full name (and name you want to be called), date of birth, address/phone #, emergency contact, signed Liability Waiver, and any pre-existing medical conditions.

Cancellation Policy

- All Deposits are Non-Refundable 3 months prior to training

- Students canceling with 14 days' notice or more are entitled to a refund of paid registrations fees, less the non-refundable, non-transferable deposit.
- Students canceling with 14 days' notice or more but wishing to transfer to a different/future training or, in some cases, a Soul Culture training will forfeit \$100.00 transfer fee and the remaining balance can be applied to any future training or training within 1 full calendar year.
- Students canceling with less than 14 days' notice are NOT entitled to a refund and forfeit the deposit. The remaining balance is kept on file as a credit to be applied to a future teacher training.
- If you leave the training while in process for any reason, and cannot make up the hours within that training session, you will need to re-enroll those hours missed via group or private training with Jaishree.
- All refunds and/or credits will be issued in US Dollars only within 30 days of the request.

Cancellation by me

We may cancel a training at any time prior to start date, due to external events that make it impossible, impractical or unsafe for me to fulfill the planned training. We may cancel due to a physical emergency or situation that makes it impossible for me to lead. If we cancel a training you may choose between applying the amounts paid toward an alternative training or receiving a full refund. We are not responsible for any incidental expenses that may have incurred as a result of your

booking such as alternative or additional accommodation arrangements or non-refundable flights.

Inclusions

Your training fee includes:

- 200 Certified Yoga Alliance hours / 180 OR 200 contact hours with lead teacher and 20 non-contact hours on your own
- SCY Teacher Training Manual

Age

- **Minimum:**
 - **General Policy:** There is no minimum or maximum age requirement to become a Certified Yoga Alliance Teacher. It will be up to you to learn the policies of studios and spaces at which you wish to share your teaching service. Students under 18 must have a parent or guardian sign their release waiver (which constitutes this Terms + Conditions Policy).

Acceptance of risk

You acknowledge that the nature of this teacher training is guided and yet adventurous in mind, body, and spirit and that your participation involves a degree of personal risk. You will be participating in yoga activities that may challenge the body physically and mentally. It is your

own responsibility to acquaint yourself with the yoga system as we move along; and you take responsibility for any injuries that may incur through the practice of yoga while training, under our direct instruction or independently. We ask you to make sure your physicians or physical therapists are aware of your training and that you get a full physical before you begin. You acknowledge that the decision to participate in a yoga teacher training is made in light of consideration of this information and you accept that you assume the personal risks attendant upon such participation.

Limitation of liability

We contract with a network of companies, government agencies and individuals to assist in the running of our teacher trainings as agent for these third parties. We are not responsible for the acts and omissions of these third parties.

To the fullest extent permitted by law:

- any liability for any loss, death, injury or damage which you may suffer (directly or indirectly) in connection with or arising out of your participation in a training, or any breach of the Booking Conditions, is excluded;
- you release me and our officers, employees, agents and representatives from any liability and expressly waive any claims you may have against me arising out of or in connection with your participation in a training;

- and any condition or warranty which would otherwise be implied by law into these Booking Conditions (Implied Warranty), is excluded;
- To the extent an Implied Warranty cannot be excluded, our liability in respect of the Implied Warranty is limited to (in our absolute discretion):
- the provision of a similar training to an equivalent value; or
- a refund of the total amount received by me from you in connection with your booking. Any claim by you is excluded to the extent that it is for indirect or consequential loss, loss of profits or economic loss, however it arises, or for indirect, special, punitive or exemplary damages.

Errors & omissions

Although we have made a concerted attempt to verify the accuracy of statements made in our training documentation including brochure, website and individual training details we cannot be held responsible for any error, omission or unintentional misrepresentation that may occur.

Severability

In the event that any term or condition contained in these Booking Conditions is unenforceable or void by operation of law or as being against public policy or for any other reason then such term or condition shall be deemed to be severed from this contract or amended

accordingly only to such extent necessary to allow all remaining terms and conditions to survive and continue as binding.

The information may be disclosed to our agents, service providers or other suppliers to enable me to operate the training. We will otherwise treat your details in accordance with our privacy policy.
